First Quarter, 2020

Balance of Payments

The current account deficit expanded by 10.2 per cent to KSh 110.9 billion in the first quarter of 2020 from KSh 100.6 billion in the corresponding quarter of 2019. On the contrary, merchandise trade deficit narrowed by 9.1 per cent to KSh 218.9 billion in the quarter under review from KSh 240.7 billion in the same quarter of 2019. The improvement in the merchandise trade balance was mainly due to a 14.0 per cent increase in exports valued on *f.o.b* basis to 179.8 billion in the first quarter of 2020.

Net inflows in international trade in services declined by 67.0 per cent to a surplus of KSh 20.4 billion in the first quarter of 2020 from a surplus of 61.9 billion in the same quarter of 2019. This was mainly due to 18.4 per cent reduction in service receipts and 15.6 per cent increase in service payments in the quarter under review. During the first quarter of 2020, diaspora remittances remained resilient and grew by 4.8 per cent to KSh 71.1 billion.

In the first quarter of 2020, net inflows in the financial account declined significantly to KSh 42.9 billion from a surplus of KSh 95.7 billion in the first quarter of 2019. The stock of official reserves increased by 6.2 per cent to 904.0 billion in the first quarter of 2020 from KSh 851.1 billion in the same quarter of 2019. However, this was a 2.1 per cent decrease compared to the fourth quarter of 2019.

Public External Debt

As shown in Table 2 bilateral, multilateral and commercial banks remained the dominant sources of public external debt each accounting for about 33 per cent of the total as at end of March 2020. The stock of multilateral public external debt grew by 27.1 per cent to KSh 1,075.9 billion as at end of March 2020 due to increased disbursements. This pushed the stock of public external debt to reach KSh 3,212.6 billion as at end of March 2020, representing 18.0 per cent increase from KSh 2,721.6 billion as at end of March 2019.

International Merchandise Trade

The balance of trade in the first quarter of 2020 improved from a deficit of KSh 266.7 billion in the first quarter of 2019 to a deficit of KSh 246.6 billion as illustrated in Figure 1. This was occasioned by a 14.0 per cent increase in the value of total exports to KSh 179.8 billion, which outweighed the increase in imports from KSh 424.5 billion in the first quarter of 2019 to KSh 426.4 billion in the first quarter of 2020. The volume of trade rose to KSh 606.2 billion in the first quarter of 2020 from KSh 582.2 billion in the first quarter of 2019, as shown in Table 3, translating to a 4.1 per cent growth.

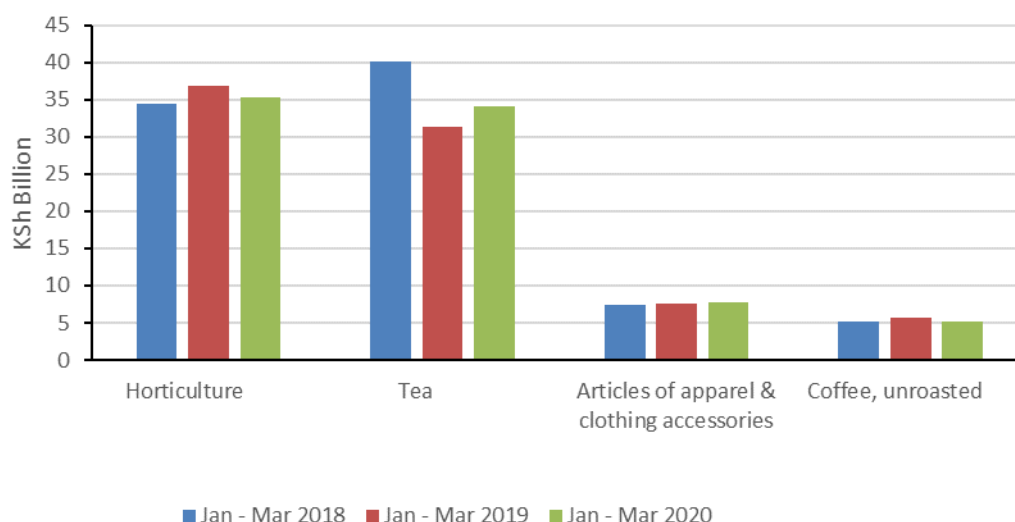

Value of Domestic Exports

In the first quarter of 2020, the value of domestic exports rose by 5.3 per cent to KSh 144.9 billion compared to KSh 137.6 billion the same quarter in 2019. This trend was largely on account of increases in some leading export commodities which included tea (8.8 %), titanium ores and concentrates (75.4 %), essential oils (31.4 %) and; edible products and preparations (39.3%). On the other hand, domestic exports of horticulture and coffee declined by 4.1 per cent and 10.2 per cent, respectively as presented in Annex 1 and Figure 2.

Domestic exports of Food and Beverages by Broad Economic Category classification in the quarter under review rose by 6.9 per cent compared to the same quarter of 2019 and accounted for 44.8 per cent of the domestic exports as highlighted in Annex 7. This was majorly attributed to a 6.6 per cent increase in exports of primary food and beverages for household consumption. Similarly, domestic exports of non-food industrial supplies rose by 10.5 per cent in the first quarter of 2020 compared to the corresponding quarter of 2019, mainly driven by increased export of primary industrial supplies (non-food).

Figure 2: Domestic Exports of Selected Commodities, 1st Quarter, 2018-2020



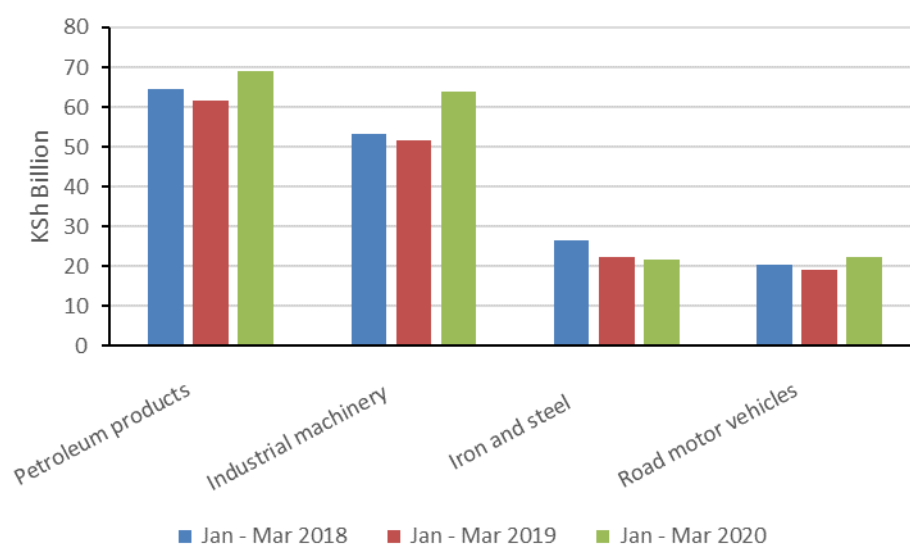
Value of Imports

Import bill rose from KSh 424.5 billion in the first quarter of 2019 to KSh 426.4 billion in the first quarter of 2020 as highlighted in Annex 3. During the quarter under review, imports of industrial machinery, petroleum products and road motor vehicles went up by 24.0, 12.1 and 16.9 per cent, respectively, compared to the same quarter of 2019, and jointly accounted for 32.8 per cent of the total imports as outlined in Figure 3. Further, an increase in the volumes of imported animal and vegetable oils; and medicinal and pharmaceutical products resulted in increased expenditure on these items by 52.2 per cent and 18.8 per cent, respectively. These commodities jointly contributed KSh 43.9 billion to the import expenditure in the first quarter of 2020 compared to KSh 32.2 billion in same quarter of 2019. Conversely, in the same period, imports of iron and steel declined by 3.5 per cent to KSh 21.6 billion.

The volume of imported wheat and rice rose by 28.8 per cent and 10.2 per cent, respectively in the first quarter of 2020 compared to a similar period in 2019, as shown in Annex 4. However, there was a marked reduction in importation of maize over the review period from 27.7 thousand tonnes in the first quarter of 2019 to 7.9 thousand tonnes in the same quarter of 2020.

Expenditure on non-food industrial supplies by Broad Economic Category continued to account for the largest portion of the import bill standing at 36.5 per cent of total imports in the first quarter of 2020 in comparison to a share of 35.2 per cent in the same period in 2019, as shown in Annex 8. Imports of processed non-food industrial supplies increased by 4.4 per cent from KSh 141.8 billion in first quarter of 2019 to KSh 148.0 billion in the first quarter of 2020. Imports of parts and accessories of machinery and other equipment went up by 89.9 per cent to KSh 19.3 billion. Similarly, imports of motor spirit rose by 34.4 per cent during the review period. On the contrary, imports of machinery and other equipment dropped by 19.7 per cent from KSh 68.7 billion in first quarter 2019 to KSh 55.1 billion in the first quarter of 2020.

Direction of International Merchandise Trade

Total export earnings improved by 14.0 per cent from KSh 157.7 billion in first quarter of 2019 to KSh 179.8 billion in the first quarter of 2020. Total exports to Asia rose from KSh 40.9 billion in first quarter of 2019 to KSh 43.8 billion in the quarter under review representing a 7.1 per cent increase, as presented in Annex 5. There were marked increases in total exports to the United Arab Emirates (24.0 %) and China (23.9%). The major contributors to this rise were

increases in the domestic exports of tea to the United Arab Emirates and titanium ores and concentrates to China, as well as increased re-exports of kerosene type jet fuel to these two destinations. Conversely, there was a decline in exports of articles of copper and disodium carbonate to India resulting to reduced earnings from this destination in the review period.

The African continent remained the leading export destination registering an increase of 22.3 per cent in the total value of exports to KSh 66.4 billion during the first quarter of 2020 from KSh 54.3 billion in the same quarter of 2019 and accounted for 36.5 per cent of the total exports. Exports earnings from Rwanda, Uganda, Sudan and South Sudan jointly increased by KSh 11.5 billion from the corresponding quarter of 2019 representing a 45.9 per cent increase. These countries jointly accounted for 55.0 per cent of the total exports to Africa during the period under review. Uganda remained the leading export destination contributing 28.4 per cent of the total export earnings from Africa. However, total exports to Burundi and Somalia fell by 35.5 per cent and 18.2 per cent, respectively.

Revenue from exports to the European Union fell by 0.7 per cent in the first quarter of 2020 compared to the same quarter of 2019. Total exports earnings from the Netherlands declined by 9.1 per cent to KSh 13.1 billion in first quarter of 2020, majorly on account of a decrease in the domestic exports of cut flowers. However, during the same period, total exports to the United Kingdom rose by 12.1 per cent to KSh 13.3 billion mainly on account of increased domestic exports of cut flowers.

There was a drop in total exports to America from KSh 13.6 billion in first quarter of 2019 to KSh 12.7 billion in the first quarter of 2020 translating to a 6.5 per cent decline, largely attributable to a 73.3 per cent decline in total exports to Canada during the period under review.

In the quarter under review imports stood at KSh 426.4 billion representing an increase of 0.4 per cent from the corresponding quarter in 2019 as indicated in Annex 6. Asia accounted for 65.7 per cent of total imports during the first quarter of 2020 at KSh 280.0 billion, representing a 7.8 per cent increase compared to same quarter of 2019. Countries that partly contributed to this increase in import expenditure from the region included India (55.7

%), China (4.6 %), Indonesia (39.8 %) and Malaysia, which more than doubled. Specifically, increased imports of gas oil, kerosene type jet fuel, and medicaments from India; parts of electric motors and generators from China; crude palm oil from Indonesia; motor spirit (gasoline) premium and crude palm oil from Malaysia, largely amplified the import bill from these sources. Nevertheless, Saudi Arabia registered a 34.5 per cent decline in imports in the same quarter, mainly on account of a drop in imports of gas oil from this source.

Import expenditure from Africa fell by 13.1 per cent to KSh 46.9 billion during the review period. This was mainly occasioned by a decline in imports of flat rolled products of iron and non-alloy steel from South Africa; processed milk and tobacco manufactures from Uganda; and sugar for industrial use from Mauritius. Nevertheless, the value of imports from Tanzania increased by 11.4 per cent, largely driven by an increase in imports of pine wood and butane petroleum gas.

America as a region exhibited an overall decline in imports by 1.5 per cent to record KSh 28.6 billion in the first quarter of 2020, despite increased imports of tractors and motor vehicles from Brazil. Similarly, imports from the European Union contracted by 17.4 per cent, valued at KSh 54.6 billion during the quarter under review. This phenomenon was largely attributable to decline in imports from the Netherlands which shrunk by 60.1 per cent on an account of significant reduction in import of dredgers from this source.
